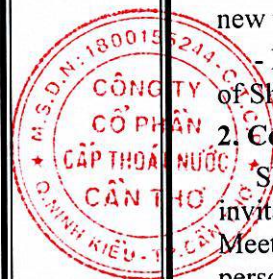

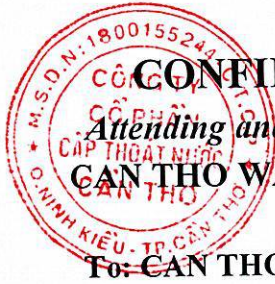

**WORKING REGULATION  
AT THE 2025 ANNUAL GENERAL MEETING OF SHAREHOLDERS  
CAN THO WATER SUPPLY - SEWERAGE JSC**

To ensure that the organization of the 2025 Annual General Meeting of Shareholders of Can Tho Water Supply - Sewerage JSC complies with the current provisions of Vietnamese law, the Board of Directors respectfully submits to the General Meeting of Shareholders of Can Tho Water Supply - Sewerage JSC the Working Regulation for the Meeting as follows:

**I. VOTING ON ISSUES AT THE GENERAL MEETING OF SHAREHOLDERS**

**1. Principles:**

Issues to be approved at the Meeting as stipulated must be approved by taking the shareholders' votes. Each shareholder or authorized representative will be issued a Voting Card and a Ballot Paper, which shall include their name, voting code, and the number of shares with voting rights.

- The Voting Card is used for voting on issues at the Meeting other than those voted on using the Ballot Paper.

- The Ballot Paper has 03 options: approve, disapprove, no opinion, corresponding to each issue to be voted on.

**2. Voting Method:**

- Shareholders or authorized representatives shall cast their votes to *approve*, or *disapprove*, or have *no opinion* on an issue approved at the Meeting, by raising their Voting Card or marking the Ballot Paper.

- When voting by Voting Card, the front side of the Voting Card (*showing the voting code*) must be raised high towards the Presidium.

- After marking the Ballot Paper for the issues to be voted on, the Shareholder or authorized Representative shall sign the Ballot Paper and submit it to the Election and Vote Counting Committee.

- The Election and Vote Counting Committee shall record the voting results of the Shareholder or authorized Representative.

**II. EXPRESSING OPINIONS AT THE MEETING**

Shareholders or authorized Representatives attending the Meeting who wish to express their opinions must:





1. Obtain the approval of the Presidium.
2. The content of the speech must be concise and relevant to the Meeting Agenda.
3. When speaking, clearly state full name and voting code.

### **III. PRESIDIUM**

- The list of the Presidium is approved by the Meeting using Voting Cards.
- Responsibilities of the Presidium:

1. Conduct the Meeting according to the agenda and regulations approved by the Meeting. The Presidium shall work on the principle of collective decision-making and decide by majority vote.

2. Guide the Meeting in discussing and voting on issues on the Meeting agenda and related issues throughout the Meeting.

3. Resolve issues arising during the course of the Meeting.

### **IV. MEETING SECRETARIAT**

- The list of the Secretariat is approved by the Meeting using Voting Cards.
- Responsibilities of the Secretariat:

1. Fully record the opinions and discussions at the Meeting and compile the reports of the Presidium.

2. Drafting the Resolutions passed at the General Meeting.

3. Preparing and approving the Minutes of the General Meeting.

### **V. ELECTION AND VOTE COUNTING COMMITTEE**

- The list of the Election and Vote Counting Committee was approved by the General Meeting by Voting Card.

- Responsibilities of the Election and Vote Counting Committee:

1. Accurately determine the voting results of the Shareholders.

2. Announce the voting results before the General Meeting after each vote.

3. Disseminate and guide the principles and rules of voting.

4. Distribute and collect Voting Cards, count votes, prepare minutes, and announce the results.

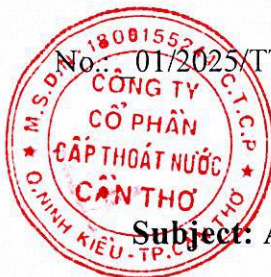
5. Review and report to the General Meeting to decide on cases of rule violations or complaints regarding voting results.

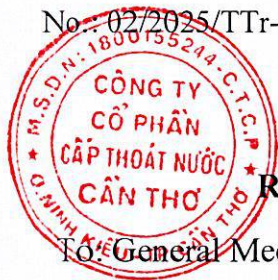

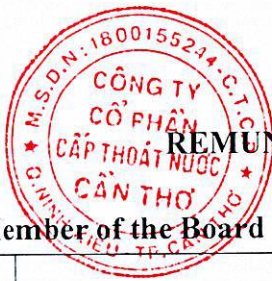

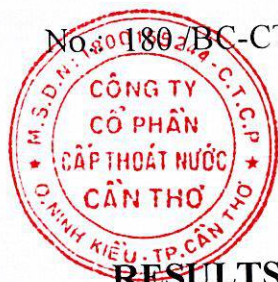

## REPORT

### RESULTS OF PRODUCTION-BUSINESS ACTIVITIES IN 2024 & ACTIVITY PROGRAM FOR 2025

Can Tho Water Supply - Sewerage JSC reports a summary of the results of production and business activities in 2024 and the activity program for 2025, as follows:

#### I. Results of Activities in 2024

##### 1. Results of achieving planned targets (according to audited financial statements):

#### 2. Capital Construction:

The total estimated investment cost in 2024 is 70.19 Billion VND. In 2024, 65.18 Billion VND was disbursed, mainly for implementing network expansion and water supply system renovation projects to serve water usage needs according to the recommendations of residents, localities, and the direction of the City Leaders, such as: (1) Renovating D110 HDPE water supply network, cutting old pipes in Company 8 residential area; (2) D225 HDPE water supply pipeline on both sides of Hoang Quoc Viet street, cutting old pipes, implementing meter policy; (3) D400 HDPE transmission pipeline - IC3 phase 1; (4) D315 HDPE pipeline (connecting to old D400 National Highway 1A pipe); (5) Renovating the 2,500 m<sup>3</sup>/day-night Bong



Vang water treatment plant cluster; (6) Water supply renovation and network expansion projects in 2024; (7) D.225, D.180, D.110 HDPE water supply pipelines, cutting old pipes - Implementing meter policy (Phase 1) for 32 streets in Ninh Kieu district; (8) D315 HDPE transmission pipeline on National Highway 61C (section from Vam Xang bridge connection road to Ba Lang bridge); (9) D400 HDPE transmission pipeline phase 1, Vo Nguyen Giap street (from Vu Dinh Lieu street to Cai Sau bridge), Cai Rang district; (10) Transitional projects from 2023 aimed at renovating and expanding the water supply network in Ninh Kieu district, Cai Rang district, and Phong Dien district,...

### **3. Water Loss and Non-Revenue Water Control Work:**

- Continue to implement clean water loss and non-revenue water control work, detect, identify, and promptly fix pipe bursts; conducted periodic inspections on 50,631 customer households, detecting 03 cases of violation of Water Usage Contracts, recovering 54,860 m<sup>3</sup> with the collected amount being 546,947,970 VND.

- Maintain and establish a pressure and flow monitoring system with 103 measurement points outside the network. Replaced cellos to improve data transmission and network-wide pressure control to support water loss control work.

- Developed a new WebGIS software for Water Supply Network Asset Management: user authorization by branch/layer/function, DMA zoning, updating pipelines, customer meters, valves, and fire hydrants.

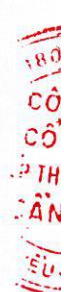
- Developed new software for automatic water loss percentage calculation to improve accuracy and better manage water loss control work.

- Completed solutions to increase water pressure on the network: changed pumping schedule and increased pumping pressure at the plant, deployed some transmission pipelines to complete water transmission axes in the area, zoned service areas for water plants, used pressure reducing valves, etc. Pressure at the water plant is from 1.0 – 2.3 bar, minimum pressure at disadvantageous points increased from 0.5 bar to 0.8 bar, average network pressure is 1 – 1.5 bar.

### **4. Professional Work:**

- Strictly comply with legal regulations on: Information disclosure for large-scale public companies on the UPCOM market (Stock symbol: CTW), tax policies, and payment of various types of insurance for officers, employees, and laborers. Successfully organized the 2024 Annual General Meeting of Shareholders and the 2024 Laborers' Representative Conference.

- The Company received the Government's Emulation Flag for excellently and comprehensively completing its tasks, leading the 2023 patriotic emulation movement of Can Tho City; a Certificate of Merit for excellent completion of tax





obligations in 2023; Recognition as a typical example in the 2024 all-people movement to protect national security.

- Implemented the application of new water prices according to Decision No. 215/QĐ-UBND Date February 01, 2024 of Can Tho City People's Committee regarding the Regulation on domestic clean water prices in Can Tho City (Decision effective from the date of signing) and Official Letter No. 457/UBND-KT Date February 01, 2024 of Can Tho City People's Committee regarding clarifying the Content in Clause 1, Article 1 of Decision No. 215/QĐ-UBND, specifically clarifying the Content as follows: "The price includes Value Added Tax, but does not include the environmental protection fee for domestic wastewater and forest environmental service fee."

- All units and professional departments achieved and completed the 2024 internal targets (except for the water loss target, which increased due to objective factors but is still lower than the 15% level stipulated by the Prime Minister by 2025), contributing to increased labor productivity, business production efficiency, enhanced sense of responsibility, thinking ability, and proactiveness of officers, employees, and laborers.

- Ensure safe and continuous water supply, with water quality meeting the standard of the Ministry of Health QCVN 01-1:2018/BYT.

- Maintain operation according to ISO 9001:2015 standard at 03 water plants and operate the laboratory according to ISO/IEC 17025:2017 standard.

- Completed the Surface water exploitation and use license and the Approval of the sanitary protection zone for the domestic water intake area at Hung Phu Water Plant 20,000 m<sup>3</sup>/day-night and Bong Vang Water Plant 15,000 m<sup>3</sup>/day-night.

- Completed participation in the Pairing cooperation program with Urban Utilities Company (Brisbane, Australia) to share experience in customer management, pipeline network, and wastewater treatment plant operation. Sent a delegation of 01 group of 03 officials to Urban Utilities Company from Date March 18, 2024 to March 23, 2024 to discuss: The company's actual management status (in the office and in the field), network zoning and separation, and management and troubleshooting of the water supply network.

- Promoted non-cash payment by advertising payment on channels: Website, Facebook, Zalo. The Percentage of payment through collection partners for the December 2024 billing period reached >99%, of which non-cash payment (via e-wallets and banks) was 90.61% (an increase of 5.01 compared to the same period in 2023).

- Regularly coordinate with relevant units to inspect and promptly fix damages related to the drainage system, clear the flow at manholes, catch basins, outlets, sewer pipes, etc., ensuring good drainage in the areas of the districts.

- Operation work of Can Tho City Wastewater Treatment Plant, capacity 30,000 m<sup>3</sup>/day-night:

+ Continue to perform well the operation work of the Wastewater Treatment Plant according to Notice No. 21/TB-VPUB Date January 28, 2019; Official Letter No. 464/UBND – XDCB Date February 09, 2022 of Can Tho City People's Committee and Official Letter No. 525/SXD-HTKT Date February 27, 2024 of Can Tho City Department of Construction regarding the operation of the Can Tho City Drainage System and Wastewater Treatment Plant Project, capacity 30,000 m<sup>3</sup>/day-night. The draft handover minutes have been submitted to the Department of Construction for review and comments before submission for signing.

+ Completed payment of operating costs for the Drainage and Wastewater Treatment Project for the years 2021, 2022, and 2023.

## **5. Research and application of science and technology and information technology in production, business management and operation:**

- Continued to operate the online clean water quality monitoring system effectively with 08 devices at the plants and on the network for real-time monitoring of 03 parameters: turbidity, pH, and Chlorine. The online river water quality monitoring system at 03 plants monitors parameters including: color, iron, Ammonia, total mineral oil and grease, salinity.

- Maintained water bill collection linkage with 15 Banks and 08 e-wallet payment methods.

- Completed improvements to the Customer Care (CTWCare) mobile application and customer care website: Improved login for security and increased access speed, fixed errors, and updated according to the new mobile operating system version.

- Deployed and officially used the incoming and outgoing document management software starting from August 2024.

- Deployed customer care on Zalo: answering questions, guiding customers. Completed the implementation of the plan to switch customers using Zalo to the CTWCare mobile application and the Company's Customer care website. Stopped allowing water bill lookup on Zalo starting from Date June 30, 2024.



- Continued to deploy electronic contracts for domestic water supply contracts.
- Continued to deploy the Power Bi application to build a Dashboard to support the summarization, reporting, and analysis of business data in the water revenue sector.

- Transformed the Information Technology Team into the Center for Monitoring and Technology Application - Digital Transformation (MDC Center).

#### **6. Social work, caring for the lives of employees and laborers:**

- Cared for policies for employees on holidays, supported local social work, etc., with the amount of 5,065,990,074 VND.

The Grassroots Trade Union organized the 2024 Sports Festival and Workers' Day; contributed 01 day's salary for flood and storm relief in the North with the amount: 139,340,909 VND; contributed to the Golden Heart Fund launched by the Can Tho City Federation with the amount: 18,660,000 VND; contributed to the Fund for the Poor launched by the Fatherland Front Committee with the amount: 72,700,000 VND.

- The Party cells organized trips to historical sites combined with tourism in 2024 for Party members and the masses.

- + D225 HDPE water supply pipeline on both sides of Hoang Quoc Viet street, cutting off old pipes, implementing meter policy; D.225, D.180, D.110 HDPE water supply pipelines, cutting off old pipes - Implementing meter policy (Phase 1) for 32 streets in Ninh Kieu district; D400 HDPE transmission pipeline - IC3 (Phase 1); National Highway 61C water supply pipeline; D315 HDPE pipeline (connecting to old D400 QL1A pipe); Renovation of the 2,500 m<sup>3</sup>/day-night cluster of Bong Vang Water Supply Branch; 5,000 m<sup>3</sup>/day-night clean water reservoir of Hung Phu Water Plant; System for recovery, treatment, and reuse of sedimentation and filtration wash water at Plant 1; CT1 Water Plant solar power system; Transitional projects in 2024



aimed at renovating and expanding the water supply network in Ninh Kieu district, Cai Rang district, and Phong Dien district.

- + Renovation projects serving water loss prevention and upgrading, expanding the water supply network as requested by local authorities, customer management units to ensure the clean water usage needs of the people.

- Enhance water loss prevention efforts after completing the pressure increase across the entire network.

- Drainage & Wastewater Treatment Project: Complete the project handover as directed by the City People's Committee and carry out procedures to sign the operation contract for 2024, 2025.

- Continue to operate the sewer lines, pumping stations & Can Tho City Wastewater Treatment Plant, with a capacity of 30,000 m<sup>3</sup>/day-night according to the approved plan.

- Continue to perform urban public utility services (maintenance, dredging of drainage systems, operation of Wastewater Treatment Plant) within the city area in 2025.

- Continue to coordinate with relevant units to inspect, survey, propose, and carry out maintenance and repair of the drainage system according to the contract signed by the Company and the requirements of the Investors.

- Continuously strive to improve the quality of drainage and wastewater treatment services to retain traditional customers. In addition, continue to seek new customers within the city area.

- Put the Monitoring and Technology Application Center - Digital Transformation into operation.

- Continue to maintain water bill payment through e-wallets and banks (achieving  $\geq 90\%$ ) to reduce the Percentage of customers using cash; Improve the automatic loss Percentage calculation software and WebGIS software; Increase the Percentage of customers using the Customer Care application (CTWCare); Develop a Customer Care Virtual Assistant.

### **III. Comments and Recommendations**

#### **1. Comments:**

Implementing the Resolution of the City People's Council, directives of the City Party Committee and the City People's Committee, the Company has always proactively expanded the network in the service area to increase the Percentage of clean water supply to the people. Taxes and insurance for Officers, Employees, and Workers are paid fully and on time. Safe, quality, and continuous clean water is provided; drainage services are promptly carried out as required by the Investors; renovation and expansion projects of the water supply network are implemented

according to the annual plan. Management and operation, customer service are constantly improved; the work execution awareness of Officers, Employees, and Workers is increasingly enhanced and more proactive, meeting the requirements in the new situation, labor utilization is more effective; employment, living conditions, and policies for Officers, Employees, and Workers are always given attention and continuously improved.

Overall, in 2024 compared to the same period in 2023, revenue increased by 49.47%, profit after tax increased by 111.41%. Revenue increased due to the water price increase from February 01, 2024, revenue from the operation of the Wastewater Treatment Plant for 03 consecutive years (2021, 2022, 2023) amounting to 35 Billion VND was recognized during the period, in addition, the Company recognized revenue (2.061 Billion VND) from the liquidation of long-standing inventory materials.

## **2. Recommendations:**

- The Department of Agriculture and Environment advises the City People's Committee to complete procedures for signing land lease contracts for the Company Office, Can Tho Water Plant 1, and An Binh Water Supply Branch; Expedite the issuance of environmental permits for 02 water plants (Can Tho Water Plant 1, Bong Vang Water Plant).
- The Department of Construction should expedite the completion of related procedures to submit to the competent authority for approval of operating cost payment for the Drainage and Wastewater Treatment Project in 2024.

## VII. Business direction for 2025

- Continue to promote digital transformation, cost savings, and increase labor productivity to enhance the efficiency of the Company's operations.

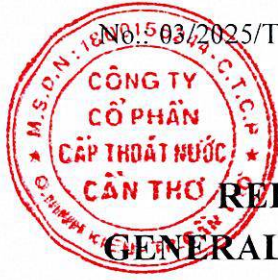

## REPORT ON SUPERVISION RESULTS FOR GENERAL DIRECTOR AND BOARD OF MANAGEMENT

Pursuant to the Law on Enterprises 2020;

Pursuant to the functions, duties, and powers of the Board of Directors stipulated in the Charter on Organization and Operation of Can Tho Water Supply - Sewerage JSC;

Pursuant to the Internal Governance Regulation of Can Tho Water Supply - Sewerage JSC issued on April 25, 2023;

Pursuant to Resolution No. 01/NQ-ĐHĐCĐ which was approved by the 2024 Annual General Meeting of Shareholders on April 26, 2024.

The Company's Board of Directors (BOD) has implemented supervision and inspection of the activities of the General Director and the Board of Management in implementing the resolutions of the General Meeting of Shareholders and the Board of Directors in 2024. The results are as follows:

### **I. Inspection and Supervision Methods:**

- Through quarterly Meetings of the Board of Directors and when there are urgent requests, the BOD has directly discussed and questioned the activities of the General Director in implementing the operational strategy and business objectives approved by the GMS on April 26, 2024. The General Director also presented difficulties and obstacles arising during the implementation of the business plan and discussed directly with the BOD to propose timely and effective solutions to successfully achieve the objectives approved by the GMS.

- The BOD has closely coordinated with the Board of Supervisors to inspect and grasp the Company's actual business situation and contribute opinions to the General Director and the Board of Management to achieve the set business targets. Members of the Board of Supervisors are all invited to attend BOD meetings, through which, the BOD and the Board of Management have the opportunity to directly exchange and discuss the contributions of the Board of Supervisors, as supervisors and representatives of investors.

- The Chairman of the Board of Directors is generally responsible, fully performs the rights and obligations according to the provisions of the Law on Enterprises and the CanThoWassco Charter; represents capital in the Company's subsidiaries.



- During the year, the General Director fully performed the rights and obligations according to the provisions of the Law on Enterprises and the CanThoWassco Charter.

- The BOD issues resolutions after each meeting to approve the plans for the next quarter and other related matters for the General Director to have a basis for implementation.

## **II. Supervision Results:**

1. In 2024, water quality was ensured, safe, and continuous for supply to the public. The Company's Board of Management collectively demonstrated a spirit of unity and high responsibility in their work. As a result, the Company's production and business activities continued to develop, achieving and exceeding the targets set by the General Meeting of Shareholders' Resolution.

2. Results of Management Activities according to the tasks assigned by the General Meeting of Shareholders:

- Revenue, Profit:

Assessment: In 2024, Can Tho city's production and business activities recovered, creating conditions to stimulate local tourism as a premise for the city's economic development. Output increased due to increased water pressure and a water price increase from February 01, 2024, contributing to the company's revenue increase. All basic targets were achieved over 100% compared to the plan assigned by the General Meeting of Shareholders.

3. Regarding Corporate Governance:

- Strictly complying with legal regulations on: Information disclosure for large-scale public companies on the UPCOM market (Stock symbol: CTW), tax policies, paying various types of insurance for employees. Successfully organizing the 2024 Employee Representatives Conference and the 2024 Annual General Meeting of Shareholders.

- Issue Internal Audit Regulations, Science and Technology Regulations, Regulations on Spending and Use of Science and Technology Development Fund.

- Implement the application of new water prices according to decision No. 215/QĐ-UBND dated February 01, 2024 of Can Tho City People's Committee regarding the regulation of clean water prices for domestic use in the area of Can Tho City.



- The units and professional departments have basically achieved and completed the internal targets for 2024, contributing to increased labor productivity, business operation efficiency, enhanced sense of responsibility and thinking ability, and proactiveness of employees.

- Ensure safe and continuous water supply, water quality meeting the standard of the Ministry of Health QCVN 01-1:2018/BYT.

- Maintain operation according to ISO 9001:2015 standard at 03 water plants and operate the laboratory according to ISO/IEC 17025:2017.

- Completed the Surface Water Exploitation and Use License and Approved the Sanitary Protection Zone for domestic water intake area at Hung Phu Water Plant 20,000 m<sup>3</sup>/day-night and Bong Vang Water Plant 15,000 m<sup>3</sup>/day-night.

- Promote non-cash payment, the percentage of non-cash payment (via e-wallets and banks) is 90.61% (an increase of 5.01 compared to the same period in 2023).

- Deployed and officially used the incoming and outgoing document management software from August 2024.

- Developed new WebGIS software for Water Supply Network Asset Management: user permission assignment by branch/layer/function, DMA zoning, updating pipelines, customer meters, valves, and fire hydrants.

- Developed new software for automatic water loss calculation to improve accuracy and better manage water loss prevention.

- Transformed the Information Technology Team into the Monitoring and Application Center of Technology - Digital Transformation (MDC Center).

### **III. Conclusion**

- Identify human resources as the central issue. Gradually plan to consolidate the organizational structure and arrange personnel to ensure effective operation according to the new model.

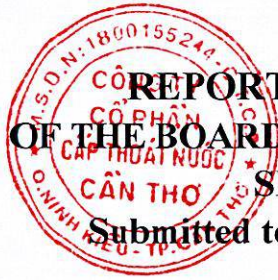

## **V. Supervision results regarding the operational situation, the implementation of accounting regulations, financial statements, and business performance results of CanThoWassco**

In 2024, CanThoWassco has basically fully met the legal requirements for a public joint stock company. Through the process of supervising the business management activities of CanThoWassco, its Company's subsidiaries, and through the verification of CanThoWassco's quarterly financial statements, semi-annual financial statements, and 2024 annual financial statements, the Board of Supervisors has the following assessment:

### **1. Regarding the operational situation of CanThoWassco**

- Strictly complied with regulations on information disclosure for large-scale public companies on the UPCOM market (Stock symbol: CTW), tax policies, and paid various types of insurance for employees. Successfully organized the 2025 Employee Conference on schedule.



- The Company received the Government's Emulation Flag for excellently and comprehensively completing its tasks, leading the patriotic emulation movement in 2023 in Can Tho City; Certificate of Merit for excellently fulfilling tax obligations in 2023; Recognized as a typical example in the 'All People Protect National Security' movement in 2024.

- Capital construction investment work: Total planned investment cost in 2024 was 70.19 Billion VND, with 65.18 Billion VND disbursed during the year, mainly implementing projects to expand the network and upgrade the water supply system to serve water usage needs according to the recommendations of residents, localities, and the direction of city leaders.

- Water loss prevention work: Continued to implement clean water loss and revenue loss prevention work, detecting, identifying, and promptly fixing pipe bursts; conducted periodic inspections on over 50,600 customer households, detected 03 cases of Water Usage Contract violations, recovered 54,860 m<sup>3</sup> with the collected amount being 546,947,970 VND. Maintained the pressure and flow monitoring system with 103 external network measurement points. Replaced cellos to improve data transmission and network-wide pressure control to support loss prevention work.

- Clean water production and business work: Ensured continuous water supply 24/7 and met the standards of the Ministry of Health. Implemented the new water price according to Decision No. 215/QĐ-UBND dated February 01, 2024 of the Can Tho City People's Committee on regulating the price of clean water for domestic use in Can Tho City.

- Organizational work: CanThoWassco continued to consolidate its organizational structure and personnel. Transformed the IT Team into the Center for Monitoring and Technology Application - Digital Transformation (MDC Center).

- Research and application of Science and Technology and Information Technology work in production, business management and operations:

+ Promoted cashless payment through advertising payment on Website, Facebook, Zalo channels. The Percentage of payments through collection partners for the December 2024 invoice period reached > 99%, of which cashless payment (via e-wallets and banks) was 90.61% (an increase of 5.01 compared to the same period in 2023).

+ Deployed and officially used the incoming and outgoing document management software from August 2024. Completed improvements to the mobile and web-based Customer Service software (CTWCare). Stopped providing water bill lookup on Zalo as of June 30, 2024.





+ Continued to effectively operate the online clean water quality monitoring system with 08 devices at plants and on the network; the online river water quality monitoring system at 03 plants.

- Drainage Project: Regularly coordinated with relevant units to inspect and promptly address damages related to the drainage system, clearing flow in manholes, catch basins, outlets, culverts, etc., ensuring good drainage in the districts. Continued to operate the wastewater treatment plant for the 38.4ha Binh Khanh resettlement area, District 2, Ho Chi Minh City and prepared payment documents as regulated.

- Regarding internal audit: The Board of Supervisors received the Q4/2024 Internal Audit Report for the Water Supply and Drainage Construction Enterprise. However, upon review, the Board of Supervisors found the report to be still general, not specific, and the Board of Supervisors has not been able to work with the person in charge of internal audit as they are on maternity leave.

## **2. Regarding the implementation of accounting regime, Financial Statements and business results**

### **2.1 Financial management:**

- The Charter capital of CanThoWassco is 280 Billion VND, of which the State holds 51% (equivalent to 142.8 Billion VND), and the remainder is held by other shareholders.

- Equity is preserved. The Board of Management of CanThoWassco needs to strengthen monitoring and direct the handling of issues related to tax policies and outstanding debts.

### **2.2 Results of the appraisal of the 2024 Consolidated Financial Statements:**

The Board of Supervisors basically agreed with the data in the 2024 Consolidated Financial Statements audited by Moore AISC Auditing and Informatics Services Co., Ltd. with the general assessment that they reflect fairly and reasonably the financial position of the Company as of December 31, 2024, specifically as follows:

### **IV. Overall Assessment of the Activities of the Board of Directors**

- The Board of Directors of Can Tho Water Supply - Sewerage Joint Stock Company has organized its activities in accordance with the provisions in the Company's Charter on organization and operation, ensuring the number of



meetings, attendance of members and observers to meet legal requirements and meeting effectiveness.

- Provided specific, feasible implementation directions and closely supervised the implementation of the Resolutions of the General Meeting of Shareholders and the Company's business production activities. Some business production results achieved:

+ Annual business results consistently exceeded the Resolution of the General Meeting of Shareholders.

+ Always preserve and develop state-owned equity (Annual capital preservation ratio >1), ensuring stable and efficient business operations.

+ Overall, during the 2020 - 2025 term, the company's output grew annually, partly due to increased customer water usage demand and partly due to the company increasing water pressure. Particularly in 2024, the highest revenue and profit growth Percentage was achieved in the 2020 - 2025 period, specifically: Revenue increased due to the water price increase from February 01, 2024, revenue from operating the Wastewater Treatment Plant for 03 consecutive years (2021, 2022, 2023) was 35 Billion VND recorded during the period; additionally, the Company recorded 2,061 Billion VND in revenue from liquidating long-standing inventory materials.

+ Strictly implement the Party's guidelines and the State's laws and policies on state divestment, increase the Percentage of clean water supply in the service area, pay taxes and social insurance for employees fully and on time. Provide safe, quality, and continuous clean water; promptly perform drainage services as required by the Investor; implement water supply network renovation and expansion projects according to the annual plan; ensure the progress of drainage and wastewater treatment projects according to the direction of the City People's Committee. Management, operation, and customer service work are constantly being improved. Detect and definitively handle cases of water usage contract violations; the work performance awareness of staff and employees is increasingly enhanced and more proactive, meeting new requirements, labor utilization is more efficient, and employment, living conditions, and policies for employees are always closely monitored and continuously improved by the unit leaders.

- The supervision of the activities of the General Director and management officers has been effectively implemented, ensuring compliance with legal regulations and the Resolutions of the Board of Directors.



- Adjust business and investment strategies flexibly and appropriately based on the principle of proactively securing water supply sources and linking regional networks to ensure the safe water supply plan for Can Tho city.

- Continue to promote digital transformation, cost savings, and increased labor productivity to enhance the Company's operational efficiency.

### **1. Board of Directors**

- The Resolutions issued by the Board of Directors had the consensus of the members, were practical, and complied strictly with the provisions of the law and the Company's Charter. The policies put forth were feasible, widely implemented, contributing to improving the business production efficiency of the Company.



## **2. Board of Management**

- The organizational structure of the Board of Management consists of 04 people: the General Director (GD) and 03 Deputy General Directors, including: the GD and 01 Deputy GD concurrently serving as Member of the Board of Directors for the 2020 - 2025 term.

- Implementing the Resolution of the Board of Directors, the Board of Management has implemented the resolutions and decisions set forth by the Board of Directors, developed detailed business production plans, and deployed them to departments and branches.

- The decisions of the Board of Management are valid, legal, within authority, and timely. Matters exceeding the authority of the Board of Management are promptly submitted to the Board of Directors for approval by Resolution.

### **III. Evaluation of some results achieved by the Company**

- Financial management: The Company's Charter capital is 280 Billion VND, of which the State holds 51% (equivalent to 142.8 Billion VND), major shareholders hold 47.60%; the remainder is held by small shareholders. Equity is preserved annually, ensuring stable and efficient business production activities. The Board of Management has provided timely guidance related to the Company's financial management. However, there are still some shortcomings pointed out by the State Audit and need to be reviewed and rectified.

- Annual business production results basically met and exceeded the Resolution of the General Meeting of Shareholders.

### **B. DIRECTION OF ACTIVITIES OF THE BOARD OF SUPERVISORS FOR THE 2025 - 2030 TERM**

- Implement and execute the annual activity plan of the Board of Supervisors.

- Has the right to request the Board of Directors' support team to prepare Content, documents, and convene meetings of the Board of Supervisors.

- The Head of the Board of Supervisors performs other rights and duties as stipulated by law.

1. Shareholders or groups of shareholders holding from 10% to less than 30% of the total voting shares are entitled to nominate a maximum of 02 candidates for the Board of Directors, and/or 01 candidate for the Board of Supervisors.

2. From 30% to less than 50% of the total voting shares are entitled to nominate a maximum of 03 candidates for the Board of Directors, and/or 02 candidates for the Board of Supervisors.

3. From 50% or more of the total voting shares are entitled to nominate a maximum of 04 candidates for the Board of Directors, and/or 03 candidates for the Board of Supervisors.

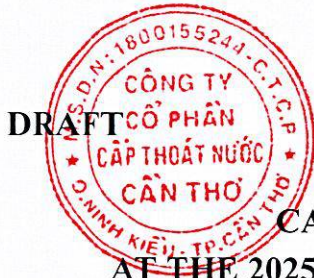

To ensure that the election of members of the Board of Directors and Board of Supervisors of Can Tho Water Supply - Sewerage JSC at the 2025 Annual General Meeting of Shareholders complies with current Vietnamese legal regulations, is conducted according to the principles of openness and democracy, and safeguards the legitimate rights of all shareholders, the draft election regulations for the Board of Directors and Board of Supervisors are hereby submitted to the General Meeting of Shareholders as follows:

**Election Principle: cumulative voting principle**

**1/. Ballots:**

- Ballots for the Board of Directors and Board of Supervisors are pre-printed with the names of candidates in alphabetical order and stamped with the seal of Can Tho Water Supply - Sewerage JSC.
- The ballot includes the election code and the total number of voting shares of the shareholders (including owned shares and authorized shares).
- Each shareholder or authorized representative shall receive 02 (two) ballots of different colors (One ballot for members of the Board of Directors and one ballot for members of the Board of Supervisors).

**2/. Election Principles:**

- The maximum number of members to be elected for the Board of Directors is: 05 (five) persons.
- The maximum number of members to be elected for the Board of Supervisors is: 03 (three) persons.
- Election Method: cumulative voting. Accordingly, each shareholder has a total number of voting votes corresponding to the total number of owned and represented shares multiplied by the number of members to be elected for the Board of Directors/ Board of Supervisors, and the shareholder has the right to cast all of their total votes for one or some candidates.

*Example:*





*A shareholder owning 1,000 shares participating in the election to select 05 members for the Board of Directors will have a total corresponding voting votes of 5,000 shares. The shareholder can distribute the votes equally among 5 candidates, giving each 1,000 shares; or can vote for candidate A 2,000 shares, candidate B 2,000 shares, candidate C 1,000 shares; or can cast all votes for candidate D 5,000 shares.*

*A shareholder owning 1,000 shares participating in the election to select 03 members for the Member of the Board of Supervisors will have a total corresponding voting votes of 3,000 shares. The shareholder can vote for candidate A 1,000 shares, candidate B 1,000 shares, candidate C 1,000 shares; or can vote for candidate A 2,000 shares, candidate B 1,000 shares; or can cast all votes for candidate A 3,000 shares.*
